

## Winter Resolution 2017 Sweepstakes

### OFFICIAL RULES

**No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.**

**Promotion Period:** Winter Resolution 2017 ("Sweepstakes") begins January 1, 2017 and ends February 28, 2017. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

**How to Enter:** Individuals will receive an automatic entry into the Sweepstakes when they log into Hiway Federal Credit Union® Money Tracker between January 1, 2017 and February 28, 2017, and have added at least one financial goal. One entry per household.

Hiway Federal Credit Union and contest sponsor – Debtfolio, Inc. dba Geezeo – are not responsible for entries that are lost, misdirected, delayed, destroyed, deleted, erased, stolen, or unreadable. Hiway Federal Credit Union and Geezeo assume no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. Mail-in entries must be postmarked no later than February 28, 2017 and received by March 6, 2017. Proof of mailing does not constitute proof of delivery. The 3X5 card **MUST BE ENCLOSED IN A NEW STANDARD, BUSINESS SIZE ENVELOPE SIZED AT 4-1/8" x 9-1/2"**. **A return address MUST BE on the envelope.** Geezeo is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries or mail. Mechanically reproduced entries will not be accepted. Alternate entries are limited to one per household and you MAY NOT send in multiple entries for multiple financial institutions. Once submitted, all entries become the property of Geezeo and none will be returned.

**Eligibility:** Entries are open to the general public. No purchase necessary. To qualify for the Sweepstakes, entrants must be a resident of the 50 United States, District of Columbia, Guam and Puerto Rico and be 18 years or older.

**Employees, Board members and consultants of Hiway Federal Credit Union and its subsidiaries, and their family members within the same household are not eligible to win.**

**Sweepstakes subject to all applicable federal, state and local laws. Sweepstakes void where prohibited or restricted by law.**

**Agreement to Official RULES:** Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Geezeo, which are final and binding in all matters relating to this Sweepstakes.

**Selection of Winners:** Winners will be chosen by random selection the week of March 6th, 2017, from all eligible entries received during the Promotion Period from all participating financial institutions. There will be a total of five (5) prizes: \$500.00 Grand Prize, \$250.00 first runner up prize, \$100.00 second runner up prize, \$100.00 third runner prize, and \$100.00 fourth runner up prize.

For a selected entry to be declared a winner, the winning individual must satisfy all of the requirements as listed in these Official Rules. Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.

Prize winners will be required to sign an affidavit of eligibility and liability/publicity release which must be returned within 10 days of notification. Winners agree to permit Geezeo and Hiway Federal Credit Union to use their name, likeness, and city of residence for advertising and promotional purposes without additional compensation except where prohibited by law. Geezeo and Hiway Federal Credit Union will make its best reasonable effort to contact all winners. If any winner cannot be contacted, an alternate winner will be randomly selected.

**Prizes:** There will be awarded five (5) prizes: \$500.00 Grand Prize, \$250.00 first runner up prize, \$100.00 second runner up prize, \$100.00 third runner prize, and \$100.00 fourth runner up prize. The arrangement of the prize distribution will be handled between the Prize Winner and Geezeo/Hiway Federal Credit Union. Geezeo/Hiway Federal Credit Union does not guarantee any specific rates or stock availability. No prize substitution is allowed.

The odds of winning are approximately 1 in 30,000; however, actual odds of winning will depend upon the number of entries received from all participating financial institutions.

Final determination of winners will be made by a staff member of Geezeo, whose decision is final.

Prizes are non-transferable and no substitution of prizes is permitted without the permission of Geezeo, which reserves the right to substitute a prize with another prize of equal or greater value. Geezeo will report all prize winnings to the appropriate state and federal agencies as required by applicable law. Your rights will be determined by a NEUTRAL ARBITRATOR and NOT a judge or jury. You are entitled to a **FAIR HEARING**, BUT the arbitration procedures are **SIMPLER AND MORE LIMITED** THAN RULES APPLICABLE IN COURT. Arbitrator decisions are as enforceable as any court order and are subject to **VERY LIMITED REVIEW** BY A COURT. The place of arbitration shall be in the County in which you reside.
